Security Deposit	Equivalent of 1.5 months rent or 2 months rent if pets allowed
Alterations after creation of contract	£50 +VAT (£60 inclusive of VAT)
Tenancy Extension/Renewal Fee	£60 +VAT (£72 inclusive of VAT) per property
Late Rental Payment Letter	£60 +VAT (£72 inclusive of VAT) per property

ADDITIONAL FINANCIAL RESPONSIBILITIES OF TENANT
